REQUEST FOR EXPRESSION OF INTEREST FOR THE CONDUCT OF THE FORMULATION OF MANAGEMENT PLAN FOR IRRIGATION WATER RESOURCES (MPIWR) OF TIGMAN-HINAGYANAN-INARIHAN RIVER IRRIGATION SYSTEM (INARIHAN RIVER WATERSHED)

- 1. The National Irrigation Administration RO V, Naga City, through the GAA/CCAW CY 2023 intends to apply the sum of P 2,776,874.34 being the Approved Budget for the Contract (ABC) to payments under the contract for the Conduct of the Formulation of Management Plan for Irrigation Water Resources (MPIWR) of Tigman-Hinagyanan-Inarihan River Irrigation System (Inarihan River Watershed), Calabanga, Camarines Sur under Contract Reference No. CCAW-CS-028-23. Bids received in excess of the ABC shall be automatically rejected at bid opening of the financial proposals.
- 2. The National Irrigation Administration RO V, Naga City now calls for the submission of eligibility documents for the Conduct of the Formulation of Management Plan for Irrigation Water Resources (MPIWR) of Tigman-Hinagyanan-Inarihan River Irrigation System (Inarihan River Watershed), Applications for eligibility will be evaluated based on a non-discretionary "pass/fail" criterion.

- 3. Interested bidders may obtain further information from *National Irrigation Administration RO V*, *Naga City* and inspect the Bidding Documents at the address given below on **August 10, 2023.**
- 4. Pre-Bid Conference will be conducted at NIA ROV Conference Room, Naga City on September 14, 2023 at 9:00 AM and can be accessed thru video conferencing for those who cannot attend at the said venue.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on 8:00 AM of August 10, 2023 to 1:30 PM of September 26, 2023 from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of five thousand pesos (P 5,000.00) for tender documents. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
- 6. The BAC shall draw up the short list of consultants from those who have submitted Expression of Interest, including the eligibility documents, and have been determined as eligible in accordance with the provisions of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act", and its Revised Implementing Rules and Regulations (RIRR). The short list shall consist of three (3) prospective bidders who will be entitled to submit bids. The criteria and rating system for short listing: Please refer to attached Eligibility Data Sheet.
- 7. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the RIRR of RA 9184. Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
- 8. The Procuring Entity shall evaluate bids using the *Quality-Cost Based Evaluation (QCBE)*, procedure. The criteria and rating system for the evaluation of bids shall be provided in the Instructions to Bidders.
- 9. The contract shall be completed within one hundred eighty (180) calendar days.

- 10. The National Irrigation Administration RO V, Naga City reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its RIRR, without thereby incurring any liability to the affected bidder or bidders.
