**REQUEST FOR EXPRESSION OF INTEREST FOR DETAILED ENGINEERING STUDY/DESIGN OF BOSIGON IRRIGATION PROJECT**

**LABO, PARACALE & VINZONS, CAMARINES NORTE**

1. The *National Irrigation Administration RO V, Naga City*, through the *GAA/FSDE CY 2022* intends to apply the sum of **P 15,959,976.00** being the Approved Budget for the Contract (ABC) to payments under the contract for the *Conduct of Detailed Engineering Study/Design of BOSIGON IRRIGATION PROJECT, Labo, Paracale & Vinzons, Camarines Norte* under **Contract Reference No. FSDE22-CN-019-23**. Bids received in excess of the ABC shall be automatically rejected at bid opening of the financial proposals.
2. The *National Irrigation Administration RO V, Naga City* now calls for the submission of eligibility documents for the *Conduct of Detailed Engineering Study/Design of BOSIGON IRRIGATION PROJECT*. Applications for eligibility will be evaluated based on a non-discretionary “pass/fail” criterion.

3. Interested bidders may obtain further information from *National Irrigation Administration RO V, Naga City* and inspect the Bidding Documents at the address given below on **May 26, 2023**
4. Pre-Bid Conference will be conducted at NIA ROV BAC Conference Room, Naga City on **June 29, 2023 at 10:00 AM** and can be accessed thru video conferencing for those who cannot attend at the said venue.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **8:00 AM of May 26, 2023 to 1:30 PM of July 11, 2023** from the address below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of twenty-five thousand pesos (P 25,000.00) for tender documents*. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
6. The BAC shall draw up the short list of consultants from those who have submitted Expression of Interest, including the eligibility documents, and have been determined as eligible in accordance with the provisions of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”, and its Revised Implementing Rules and Regulations (RIRR). The short list shall consist of *three (3)* prospective bidders who will be entitled to submit bids. The criteria and rating system for short listing: Please refer to attached Eligibility Data Sheet.
7. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the RIRR of RA 9184. Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
8. The Procuring Entity shall evaluate bids using the *Quality-Cost Based Evaluation (QCBE)*, procedure. The criteria and rating system for the evaluation of bids shall be provided in the Instructions to Bidders.
9. The contract shall be completed within *three hundred sixty (360) calendar days*.
10. The *National Irrigation Administration RO V, Naga City* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its RIRR, without thereby incurring any liability to the affected bidder or bidders.
