- 5. A complete set of Bidding Documents may be acquired by interested bidders on 8:00 AM of November 22, 2023 to 1:30 PM of December 12, 2023 at the given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of P 25,000.00. The Procuring Entity shall allow the bidder to present its proof of payment for the fees to be presented in person, by facsimile, or through electronic means.
- 6. The *National Irrigation Administration RO V*, *Naga City* will hold a Pre-Bid Conference¹ on **November 30, 2023** at **10:00 AM** at *NIA RO V BAC Conference Room, Naga City* and/or through videoconferencing/webcasting which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address as indicated below, (ii) online or electronic submission as indicated below, or (iii) both} on or before *December 12, 2023 at 1:30 PM*. Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
- 9. Bid opening shall be on *December 12, 2023 at 1:30 PM* at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

May be deleted in case the ABC is less than One Million Pesos (PhP1,000,000) where the Procuring Entity may not hold a pre-bid conference.
