Invitation to Bid for RESTORATION OF CANAL AND CANAL STRUCTURES OF STA. TERESITA CIS

1. The *National Irrigation Administration CSIMO, Sta. Lucia, Magarao, Camarines Sur*, through the *GAA/RESTOCIS CY 2024* intends to apply the sum of **P 2,146,428.71** being the Approved Budget for the Contract (ABC) to payments under the contract for the **RESTORATION OF CANAL AND CANAL STRUCTURES OF STA. TERESITA CIS, Canaman, Camarines Sur with Contract Reference No. RESTOCIS-CS-THIRIS-042-24**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *National Irrigation Administration CSIMO, Sta. Lucia, Magarao, Camarines Sur* now invites bids for the above Procurement Project. Completion of the Works is required **two hundred twenty (220) calendar days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from *National Irrigation Administration CSIMO, Sta. Lucia, Magarao, Camarines Sur* and inspect the Bidding Documents at the address given below from **8:00 AM of July 5, 2024 to 3:00 PM of July 25, 2024**.
5. A complete set of Bidding Documents may be acquired by interested bidders on **8:00 AM of July 5, 2024 to 3:00 PM of July 25, 2024** at the given address and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **P 5,000.00**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees to be presented in person only.
6. The *National Irrigation Administration CSIMO, Sta. Lucia, Magarao, Camarines Sur* will hold a Pre-Bid Conference¹ on **July 15, 2024 at 3:00PM at NIA-CSIMOHO, Sta. Lucia, Magarao, Camarines Sur**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address as indicated below, on or before **3:00 PM of July 25, 2024**. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
9. Bid opening shall be on **3:00 PM of July 25, 2024** at the given address below. Bids will be opened in the presence of the bidders’ representatives who choose to attend the activity.
10. The *National Irrigation Administration CSIMO, Sta. Lucia, Magarao, Camarines Sur* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.

¹ May be deleted in case the ABC is less than One Million Pesos (PhP1,000,000) where the Procuring Entity may not hold a pre-bid conference.
