Invitation to Bid for Renovation of the Material Testing Building at NIA RO 5, Panganiban Drive, Naga City

- 1. The National Irrigation Administration RO V, Naga City, through the GAA/CO CY 2024 intends to apply the sum of P 4,975,135.49 being the Approved Budget for the Contract (ABC) to payments under the contract for the Renovation of the Material Testing Building at NIA RO 5, Panganiban Drive, Naga City with Contract Reference No. CO-RO-050-24. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The National Irrigation Administration RO V, Naga City now invites bids for the above Procurement Project. Completion of the Works is required one hundred twenty (120) calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 4. Interested bidders may obtain further information from *National Irrigation Administration RO V*, *Naga City* and inspect the Bidding Documents at the address given below from 8:00 AM of August 5, 2024 to 9:00 AM of August 27, 2024.
- 5. A complete set of Bidding Documents may be acquired by interested bidders on 8:00 AM of August 5, 2024 to 9:00 AM of August 27, 2024 given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of P 5,000.00. The Procuring Entity shall allow the bidder to present its proof of payment for the fees to be presented in person, by facsimile, or through electronic means.
- 6. The *National Irrigation Administration RO V, Naga City* will hold a Pre-Bid Conference on **August 12, 2024**, at **9:00 AM** at *NIA RO V, Large Conference Room*, *Panganiban Drive, Naga City* and/or through videoconferencing/webcasting which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address as indicated below, (ii) online or electronic submission as indicated below, or (iii) both} on or before 9:00 AM of August 27, 2024. Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
- 9. Bid opening shall be on *August 27, 2024 at 9:00 AM* at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
