Invitation to Bid for the *Supply, Delivery, Installation of AI Satellite Monitoring & Fertigation System, 8 units Solar Power Pump including accessories, Construction of Irrigation Facilities and 1 unit drilling for Alas SPIP, Boracay SPIP, Buyo SPIP, Jagnaan SPIP, Lumbang SPIP, Tagpu-2 SPIP, Tumalaytay SPIP, and Vito SPIP, San Fernando, San Jacinto, Milagros, Mandaon, Masbate City, Masbate*

1. The *National Irrigation Administration RO V, Naga City*, through the *GAA/EGPIP CY 2025* intends to apply the sum of **P 135,845,933.10** being the Approved Budget for the Contract (ABC) to payments under the contract for the *Supply, Delivery, Installation of AI Satellite Monitoring & Fertigation System, 8 units Solar Power Pump including accessories, Construction of Irrigation Facilities and 1 unit drilling for Alas SPIP, Boracay SPIP, Buyo SPIP, Jagnaan SPIP, Lumbang SPIP, Tagpu-2 SPIP, Tumalaytay SPIP and Vito SPIP, San Fernando, San Jacinto, Milagros, Mandaon, Masbate City, Masbate with Contract Reference No. EGPIP-MS-036-25. Bids received in excess of the ABC shall be automatically rejected at bid opening.*
2. The National Irrigation Administration RO V, Naga City now invites bids for the Supply, Delivery, Installation of AI Satellite Monitoring & Fertigation System, 8 units Solar Power Pump including accessories, Construction of Irrigation Facilities and 1 unit drilling for Alas SPIP, Boracay SPIP, Buyo SPIP, Jagnaan SPIP, Lumbang SPIP, Tagpu-2 SPIP, Tumalaytay SPIP and Vito SPIP, San Fernando, San Jacinto, Milagros, Mandaon, Masbate City, Masbate Completion of the Works is required **three hundred sixty (360)** calendar days from receipt of Notice to Proceed. Bidders should have completed a single contract within five (5) years from the date of submission and receipt of bids, a contract similar to the Project with a value of at least fifty percent (50%) of ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Interested bidders may obtain further information from *National Irrigation Administration RO V, Naga City* and inspect the Bidding Documents at the address given below from **8:00 AM of May 28, 2025 to 1:30 PM of June 17, 2025**.
5. A complete set of Bidding Documents may be acquired by interested bidders from **8:00 AM of May 28, 2025 to 1:30 PM of June 17, 2025** at the given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **P 50,000.00**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees to be presented in person, by facsimile, or through electronic means.
6. The National Irrigation Administration RO V, Naga City will hold a Pre-Bid Conference¹ on **June 5, 2025 at 9:00 AM** at NIA RO V, EOD Conference Room, Panganiban Drive, Naga City and/or through videoconferencing/webcasting which shall be open to prospective bidders.

¹ May be deleted in case the ABC is less than One Million Pesos (PhP1,000,000) where the Procuring Entity may not hold a pre-bid conference.


7. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address as indicated below on or before **June 17, 2025 at 1:30 PM**. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
9. Bid opening shall be on **June 17, 2025 at 1:30 PM** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The **National Irrigation Administration RO V, Naga City** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
 - Required PCAB Registration: at least **MEDIUM A** – Irrigation & Flood Control and SP-EE (Elec. Work), SP-ME (Mech. Work), SP-EM (Electro-Mech work) in other classifications.
