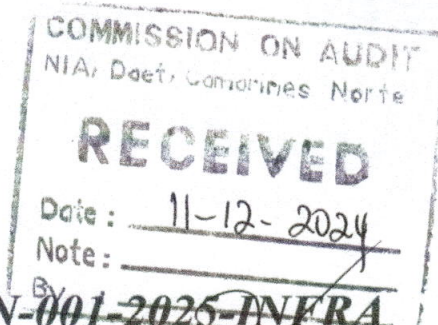






RESTORATION OF DAET-TALISAY RIVERS IRRIGATION SYSTEM
Vinzons, Camarines Norte

1. The *National Irrigation Administration-Camarines Norte IMO* with office address at *Brgy. Lag-on, Daet, Camarines Norte*, through the *GAA-CY 2025* intends to apply the sum of *Fifteen Million Eighty One Thousand Five Hundred Ten & 87/100 Pesos Only (Php 15,081,510.87)* being the Approved Budget for the Contract (ABC) to payments under the contract for *Restoration of Daet-Talisay Rivers Irrigation System*, located in the municipality of *Vinzons, Camarines Norte* with contract Reference No. *RNIS-CN-001-2025-INFRA*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *National Irrigation Administration-Camarines Norte IMO* with office address at *Brgy. Lag-on, Daet, Camarines Norte* now invites bids for the above Procurement Project. Completion of the Works is required *Three Hundred Sixty (360) Calendar Days*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from *National Irrigation Administration-Camarines Norte IMO* and inspect the Bidding Documents at the address given below from *8:00 AM to 5:00PM Monday to Friday*.
5. A complete set of Bidding Documents may be acquired by interested bidders on *8:00 AM of November 11, 2024 to 9:30 AM of December 2, 2024* from given address and website/s below *upon payment of non-refundable fee to the NIA- Cashier, the amount of Twenty Five Thousand Pesos (Php 25,000.00) for bidding documents, One Thousand Pesos (Php 1,000.00) for annual registration fee and Three Hundred Pesos (Php 300.00) for Eligibility Screening*. The Procuring Entity shall allow the bidder to present its proof of payment for the fees **before dropping of Bidding Documents**.
6. The *National Irrigation Administration-Camarines Norte IMO* will hold a Pre-Bid Conference¹ on *November 19, 2024 at 9:30 AM (BAC Office Clock)* at *BAC Office, DTRIS Building, NIA Compound, Brgy. Lag-on, Daet, Camarines Norte*.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below, on or before **9:30 AM (BAC Office Clock) of December 2, 2024**. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 16**.


