1. The **National Irrigation Administration-Camarines Norte IMO** with office address at **Brgy. Lag-on, Daet, Camarines Norte**, through the **GAA-CY 2025** intends to apply the sum of **One Million One Hundred Ninety Five Thousand Three Hundred Thirty Five & 58/100 Pesos Only (Php 1,195,335.58)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Repair of Daet-Talisay Rivers Irrigation System**, located in the municipality of **Basud, Camarines Norte** with contract Reference No. **RNIS-CN-021-2025-INFRA**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **National Irrigation Administration-Camarines Norte IMO** with office address at **Brgy. Lag-on, Daet, Camarines Norte** now invites bids for the above Procurement Project. Completion of the Works is required **Two Hundred Seventy (270) Calendar Days**. Bidders should have completed a contract similar to the Project. 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

The Procuring Entity shall allow the bidder to present its proof of payment for the fees **before dropping of Bidding Documents**.
