

**REQUEST FOR EXPRESSION OF INTEREST FOR**  
**Conduct of Social and Environmental Impact Assessment with Formulation of Preliminary**  
**Land Acquisition and Resettlement Plan for the WARAS Small Reservoir Irrigation Project,**  
**Nabua and Iriga City, Camarines Sur**

1. The *National Irrigation Administration RO V, Naga City*, through the *GAA/FSDE CY 2024* intends to apply the sum of **P 4,140,865.10** being the Approved Budget for the Contract (ABC) to payments under the contract for the *Conduct of Social and Environmental Impact Assessment with Formulation of Preliminary Land Acquisition and Resettlement Plan for the WARAS Small Reservoir Irrigation Project, Nabua and Iriga City, Camarines Sur* under Contract Reference No. **FSDE-CS-082-24**. Bids received in excess of the ABC shall be automatically rejected at bid opening of the financial proposals.
2. The *National Irrigation Administration RO V, Naga City* now calls for the submission of eligibility documents for *Conduct of Social and Environmental Impact Assessment with Formulation of Preliminary Land Acquisition and Resettlement Plan for the WARAS Small Reservoir Irrigation Project*. Eligibility documents of interested consultants must be duly received by the BAC Secretariat on or before **November 19, 2024 at 8:00am to 5:00pm** at *National Irrigation Administration RO V, Naga City*. Applications for eligibility will be evaluated based on a non-discretionary "pass/fail" criterion.

3. Interested bidders may obtain further information from *National Irrigation Administration RO V, Naga City* and inspect the Bidding Documents at the address given below during **November 11, 2024**.
4. A complete set of Bidding Documents may be acquired by the shortlisted bidders on **November 28, 2024 to December 10, 2024 at 1:30pm** from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **five thousand pesos (P 5,000.00)** for tender documents. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
5. The BAC shall draw up the short list of consultants from those who have submitted Expression of Interest, including the eligibility documents, and have been determined as eligible in accordance with the provisions of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act", and its Implementing Rules and Regulations (IRR). The short list shall consist of *three (3)* prospective bidders who will be entitled to submit bids. The criteria and rating system for short listing are:
  - Applicable experience of the consultant and members in case of joint ventures, considering both the overall experiences of the firm or, in the case of new firms, the individual experiences of the principal and key staff, including the times when employed by other consultants= 30%.



- Current workload relative to the capacity = 20%, with a total of 100%.


*Passing Score: 75%*

6. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the IRR of RA 9184. Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
7. The Procuring Entity shall evaluate bids using the *Quality-Cost Based Evaluation/Selection (QCBE/QCBS)* procedure. The criteria and rating system for the evaluation of bids shall be provided in the Instructions to Bidders.
8. The contract shall be completed within *one hundred eighty (180) calendar days*.
9. The *National Irrigation Administration RO V, Naga City* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
