***Repair/Rehabilitation of Protection Works and Canalization Works
of PRISA LEFT QUINALE CIS, Oas & Libon, Albay***

1. The ***National Irrigation Administration RO V, Naga City***, through the ***GAA/ CY 2023*** intends to apply the sum of ***₱ 42,697,621.19*** being the Approved Budget for the Contract (ABC) to payments under the contract for the ***Repair/Rehabilitation of Protection Works and Canalization Works of PRISA LEFT QUINALE CIS, Oas & Libon, Albay with Contract Reference No. REPCIS-AL-037-23***. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The ***National Irrigation Administration RO V, Naga City*** now invites bids for the above Procurement Project. Completion of the Works is required ***one hundred ten (110) calendar days***. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from ***National Irrigation Administration RO V, Naga City*** and inspect the Bidding Documents at the address given below from ***8:00 AM of July 11, 2022 to 1:30 PM of July 31, 2023***.
5. A complete set of Bidding Documents may be acquired by interested bidders on ***8:00 AM of July 11, 2023 to 1:30 PM of July 31, 2023*** given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of ***₱ 25,000.00***. The Procuring Entity shall allow the bidder to present its proof of payment for the fees to be presented in person, by facsimile, or through electronic means.
6. The ***National Irrigation Administration RO V, Naga City*** will hold a Pre-Bid Conference¹ on ***July 19, 2023 at 10:00 AM at NIA RO V BAC Conference Room, Naga City*** and/or through videoconferencing/webcasting which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address as indicated below, (ii) online or electronic submission as indicated below, or (iii) both} on or before ***1:30 PM of July 31, 2023***. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ***ITB Clause 16***.

¹ May be deleted in case the ABC is less than One Million Pesos (PhP1,000,000) where the Procuring Entity may not hold a pre-bid conference.

9. Bid opening shall be on **July 31, 2022 at 1:30 PM** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The **National Irrigation Administration RO V, Naga City** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.


